

**ATTACHMENT B**  
**DFARS and Related Provisions**

1. The following DFARS clauses and provisions shall apply, as required by the terms of the prime contract or by operation of law or regulation. The effective version of each DFARS provision shall be the same version as that which appears in the Prime Contractor's Prime Contract.
2. The following clauses set forth in the DFARS in effect as of the date of the prime contract are incorporated herein by reference. In all clauses listed herein, the terms "Government", "Contracting Officer" and "Contractor" shall be revised to suitably identify the contracting parties herein and affect the proper intent of the provision except where further clarified or modified below. "Subcontractor", however, shall mean the Subcontractor identified in this Subcontract Agreement.  
IT IS THE SOLE RESPONSIBILITY OF SUPPLIER TO COMPLY WITH THE FAR, DFARS AND/OR OTHER RELATED CLAUSES APPLICABLE TO SUPPLIER, THE SUBJECT MATTER OF THE PURCHASE ORDER, AND THE PRIME CONTRACT. THE FAR, DFARS AND/OR OTHER RELATED CLAUSES SET FORTH HEREIN ARE INCLUDED AS AN EASE OF REFERENCE FOR SUPPLIER ONLY AND ARE NOT INTENDED TO SET FORTH A COMPLETE AND ACCURATE ITEMIZATION OF THE FAR, DFARS AND/OR OTHER RELATED CLAUSES APPLICABLE TO SUPPLIER, THE SUBJECT MATTER OF THE PURCHASE ORDER, OR THE PRIME CONTRACT.
